INSPECTIONS REQUIRED

Underground Inspection – shall be made after trenches or ditches are excavated and bedded, piping installed, and before any backfill is put in place.

Rough In Inspection – shall be made after the roof, framing, fire blocking, fire topping, draft stopping and bracing is in place and all sanitary storm and water distribution piping is roughed in and prior to the installation of wall or ceiling membranes.

Final Inspection – shall be made after the building is complete, all plumbing fixtures are in place and properly connected, and the structure is ready for occupancy.

SECTION VI

I hereby apply for a plumbing permit and I certify that the information above is complete and accurate. The work will be in conformance with the 2000 Edition of the International Plumbing Code and ordinances of West Brandywine Township.

INSPECTIONS MUST BE SCHEDULED THROUGH THE CODES DEPARTMENT BY EITHER THE OWNER OR CONTRACTOR. Request for inspections must be scheduled 24 to 48 hours in advance. Twenty-four hour notice is required to cancel a scheduled inspection. Failure to cancel will result in a failed inspection. See Fee Schedule for failed inspection fee. Inspections are scheduled between the hours of 7:30 am and 11:30 am
