## Ordinance No. 2019-02

AN ORDINANCE TO AMEND TOWNSHIP CODE CHAPTER 31, ENTITLED PARKS AND RECREATION BOARD," TO REVISE THE NUMBER OF MEMBERS OF THE BOARD.

**Section 1. Membership.** Township Code Section 31-2, entitled "Membership; vacancies", shall be repealed and replaced as follows:

§31-2. Membership; vacancies.

The said Board:

- A. Shall consist of five (5) members who shall be residents of West Brandywine Township.
- B. Shall be appointed by the Board of Supervisors.
- C. Shall be appointed for a term of five years, with members to serve five-year staggered terms as of January 1 of each year.
- D. A vacancy on the said Board shall be filed by the Board of Supervisors for the remainder of the unexpired term.
- E. The Board shall have the right to make recommendations to the Board of Supervisors for proposed appointees to the Board to fulfill full or unexpired terms.

**Section 2. Severability.** If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.


**Section 3. Renumbering.** The location and numerical designation of these above-referenced Sections shall be delegated to the discretion of the General Code Publishers which may renumber or reorder these revised Sections as is necessary.

**Section 4. Effective Date.** This Ordinance shall take effect five (5) days after its enactment by the Township Board of Supervisors.





Section 2: Severability: Provides for the severability of any part of the Ordinance found to be invalid; Section 3: Renumbering: provides that the General Code Publishers shall have discretion to renumber or reorder the revised sections; Section 4: Effective Date. provides for the effective date of the Ordinance.
